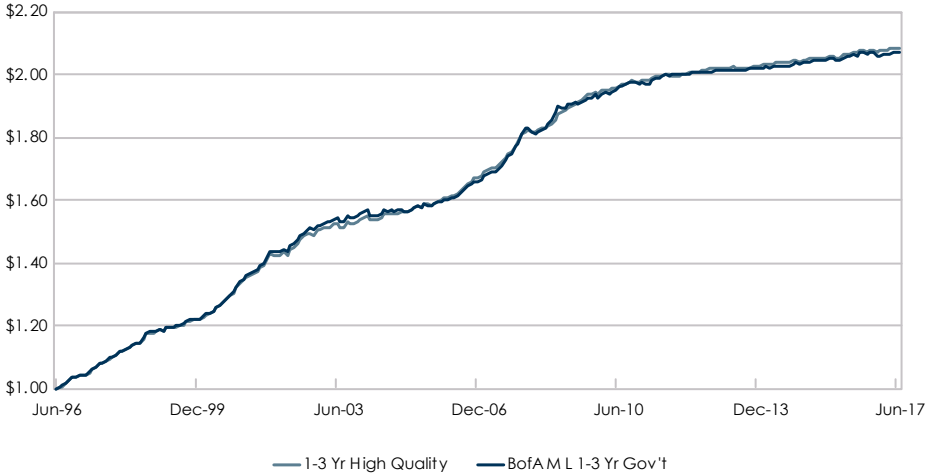

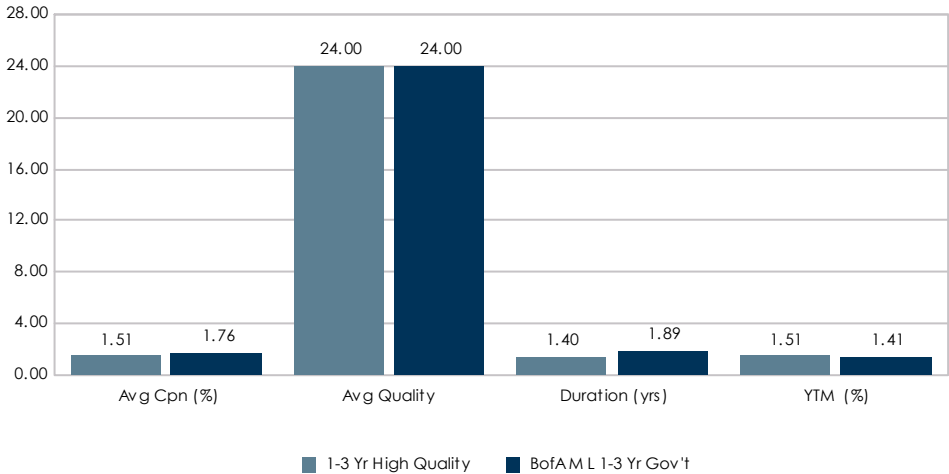

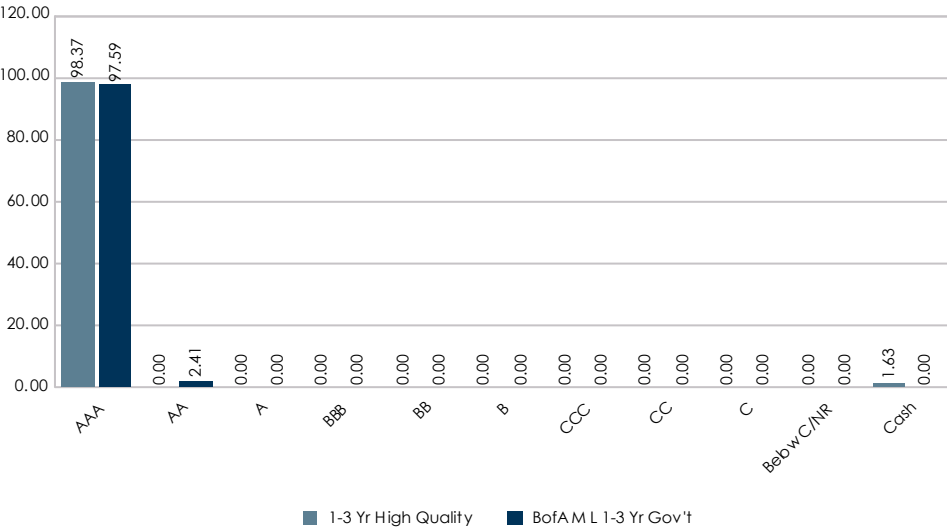
#### Growth of a Dollar



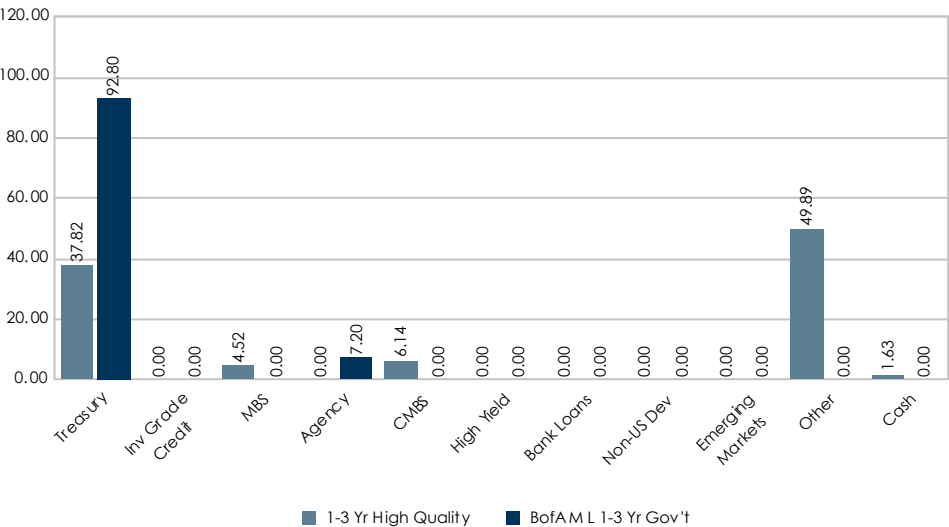
#### Characteristics



#### Quality Allocation



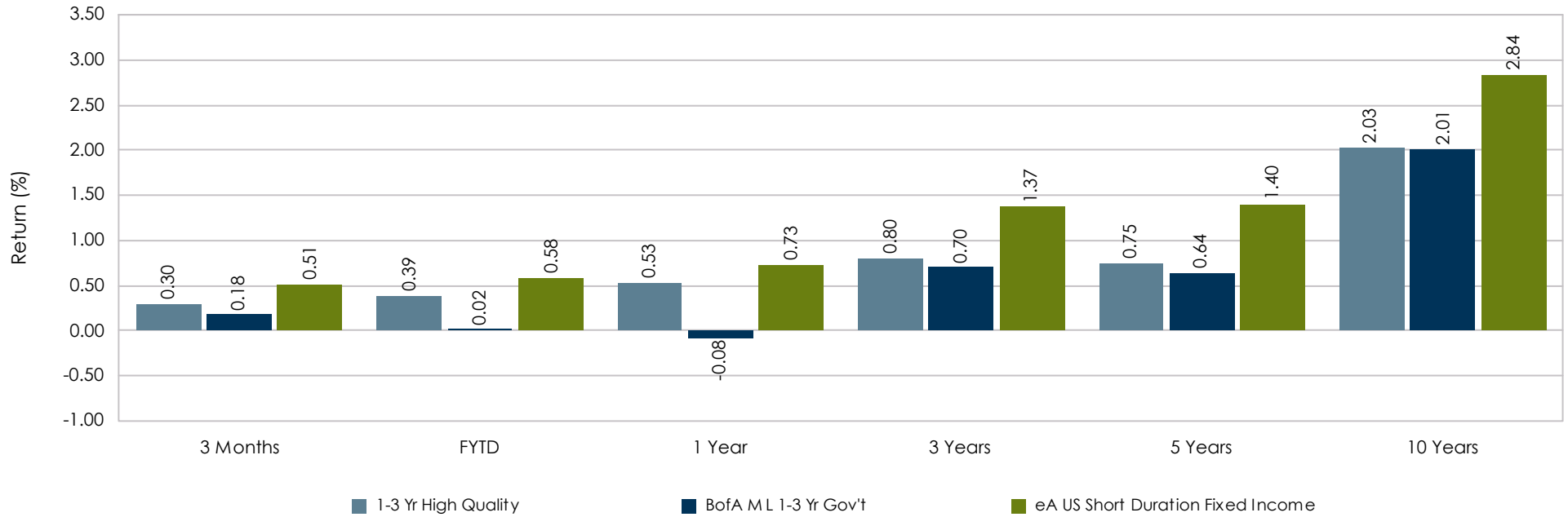
#### Sector Allocation

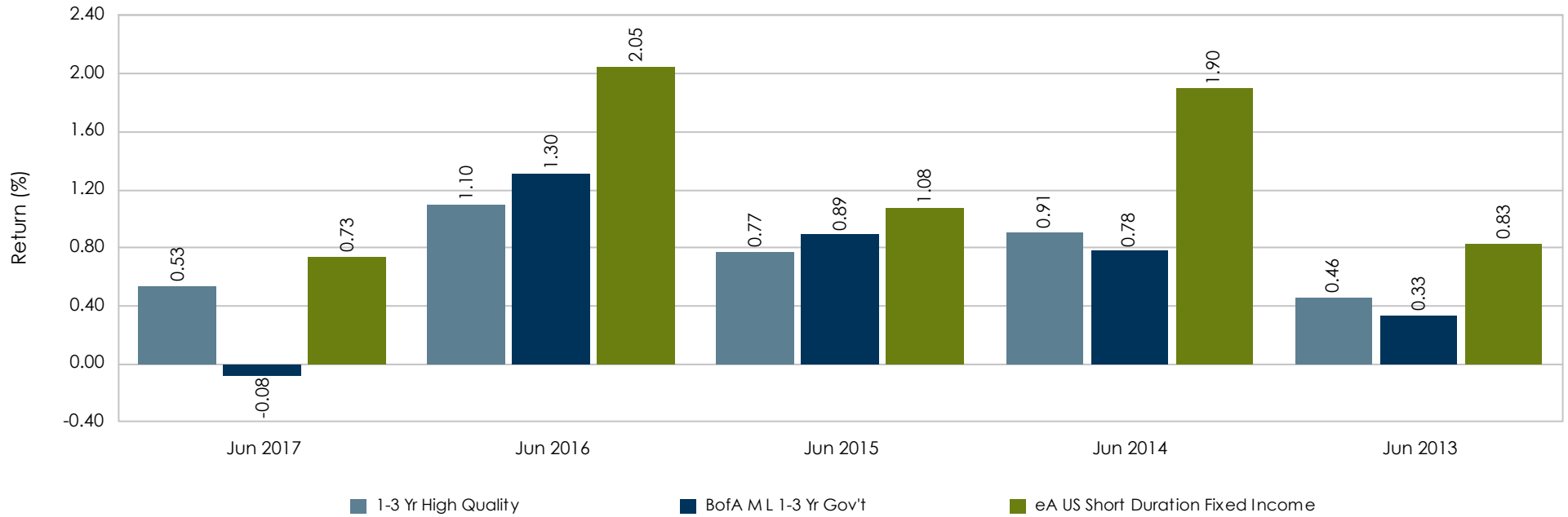
