Florida League of Cities, Inc. Annual Conference August 15-17, 2024 Diplomat Beach Resort, Hollywood, Florida

The Florida League of Cities' Annual Conference was held at the Diplomat Beach Resort in Hollywood, Florida, on August 15-17, 2024. There was an attendance of more than 800 delegates and guests, representing approximately 241 municipal governments.

Principal speakers included Richard Florida, world's leading urbanist and international bestselling author of "The Rise of the Creative Class", and Erica Dhawan, internationally recognized leading authority, speaker, and advisor on 21st-century teamwork, collaboration and innovation.

On Thursday, August 15, delegates began arriving for various workshops and events of the annual conference. In the morning, a "Continuing Education in Ethics" workshop was held. That afternoon, the League's legislative policy committees conducted a joint meeting. Three workshops, "Cities 101", "Speaking So They Hear You!", and "Retail Matters: From Downtown to Big Box" were also held. The FLC Nominating Committee met in the afternoon, as well as the Resolutions Committee. A Speed Networking event was held for first-time attendees. That evening, the President's Welcome Reception was held for all conference delegates to attend.

Friday, August 16, began with the Federal Action Strike Team (FAST) meeting, followed by three concurrent sessions "Blueprints for Change: Best Practice Solutions for Florida's Housing Crisis", "Best Practices for Natural Disasters: A Guide for Elected Officials" and "Using Al". These were followed by the Opening General Session presided by Greg Ross, FLC President, Mayor, Cooper City. The session welcome address was given by Jeannie Garner, Florida League of Cities Executive Director and CEO. At this time, Mayor Gib Coerper, Alachua, was announced as the winner of the E. Harris Drew Municipal Official Lifetime Achievement Award, and the Defender of Home Rule Award was presented to Senator Jason Pizzo. Richard Florida, world's leading urbanist and international bestselling author of "The Rise of the Creative Class," was the keynote speaker.

That afternoon, three additional rounds of concurrent sessions were held. Round two topics were: "Citizen Engagement: Communicating Your Budget", "Homelessness in Public Areas: Practical Approaches to HB 1365", and "Understanding the Grand Puzzle: Setting up for Success." Round three topics were: "Unified Leadership: Building Collaborative Council-Manager Relationships" and "Building Rapport: How to Get Along Without Giving Up". Round four topics were: "Leadership Workshop" and "The Future of Municipal Service Delivery".

Also, that day, the Advocacy Committee met, and the Florida Black Caucus of Local Elected Officials held a breakfast meeting. The Board of Directors met Friday afternoon, and in the evening a Florida League of Cities Membership Networking Reception was held, and a Young Elected Municipal Officials Dessert Reception was held.

On Saturday, August 17, several local/regional leagues held breakfast meetings.

At 9:00 a.m. that morning, President Greg Ross, Mayor, Cooper City, called the Business Session to order and announced that a quorum of delegates was present. Voting delegates were requested to be seated in the designated area. President Ross advised delegates that if it were necessary for a Division of the House to be called, an explanation of the system of casting weighted votes would be provided in advance.

The first order of business was a motion duly made and seconded to approve the 2023 conference minutes as posted on the League's website. The motion was adopted.

President Ross then recognized the chairs of the League's five legislative policy committees and thanked them and committee members for their service.

He also recognized the chairs of the Federal Action Strike Team and the Advocacy Committee thanking them for their service. He then announced there was no unfinished business to come before the membership of the Florida League of Cities.

President Ross called for a report of the Resolutions Committee. Committee Chair Michael Blake, League First Vice President and Mayor, Cocoa, introduced each resolution and moved its adoption. Each motion was duly seconded, and each resolution was adopted.

A RESOLUTION OF THE FLORIDA LEAGUE OF CITIES, INC., URGING CONGRESS TO REFORM AND INCREASE FUNDING TO THE HAZARD MITIGATION ASSISTANCE GRANT PROGRAMS.

WHEREAS, natural disasters, including hurricanes, floods, wildfires and earthquakes, pose an ongoing threat to communities in Florida and across the United States and result in loss of life, property damage and economic hardship; and

WHEREAS, Hazard Mitigation Assistance (HMA) grants, administered by the Federal Emergency Management Agency (FEMA), provide crucial funding for projects that reduce or eliminate long-term risk to people and property from natural disasters; and

WHEREAS, the HMA program includes the Pre-Disaster Mitigation (PDM) grant program, the Flood Mitigation Assistance (FMA) grant program, the Building Resilience Infrastructure and

Communities (BRIC) grant program and the Hazard Mitigation Grant Program (HMGP), all of which are essential in helping communities prepare for and recover from natural disasters; and

WHEREAS, current funding levels for the grants within the HMA Program are insufficient to meet the growing demand for mitigation projects, which leaves many communities vulnerable to the devastating impacts of natural disasters; and

WHEREAS, there continues to be a dire need for reforms to the HMA Program to streamline the application process, prioritize equitable and cost-effective distribution of funds and increase support for underserved and disadvantaged communities disproportionately affected by natural hazards; and

WHEREAS, strengthening the HMA Program would provide additional support for state and local governments working to implement effective hazard mitigation strategies, increase resilience and promote sustainable development in vulnerable areas; and

WHEREAS, a study from the National Institute of Building Sciences found that every dollar spent on disaster mitigation saves six dollars in future disaster costs, which reduces the long-term burden on taxpayers; and

WHEREAS, investing in hazard mitigation is not only a matter of public safety but also an investment in the economic stability and resilience of communities across the nation.

NOW, THEREFORE, BE IT RESOLVED BY THE FLORIDA LEAGUE OF CITIES, INC.:

Section 1. The Florida League of Cities, Inc. urges the United States Congress to increase funding for Hazard Mitigation Assistance Grants to meet the rising needs of communities facing natural hazards.

Section 2. The Florida League of Cities, Inc. calls upon Congress to implement reforms to the HMA Program that streamline the application process, prioritize equitable and cost-effective distribution of funds and provide targeted support for underserved and disadvantaged communities.

Section 3. A copy of this resolution be sent to President Joe Biden, the Florida congressional delegation, the National League of Cities and the membership of the Florida League of Cities, Inc.
