

Summary of the February 2, 2026, FLC Monday Morning Webinar

Charles Chapman Update:

- [HB 6027](#) (Fabricio) and [SB 1184](#) (Rodriguez) **Homestead Assessment Limitation Transfer – Monitor** – HB 6027 will be heard today, February 2, at 3:30 p.m. in the House Ways & Means Committee. This is the first of three committee stops in the House. SB 1184 has three committee references and has not yet received a committee hearing.
- [HB 103](#) (Botana) and [SB 122](#) (Truenow) **Local Business Taxes – Oppose** – HB 103 will be heard on Tuesday, February 3, at 8:00 a.m. in the House State Affairs Committee. This is the final committee stop in the House. SB 122 passed its first committee of reference and has two more committee stops in the Senate. The next committee stop in the Senate is the Senate Finance and Tax Committee.
Ask: If your senator serves on the [Senate Finance and Tax Committee](#), contact them to express your opposition to SB 122 and urge them not to hear the bill in committee.

David Cruz Update:

- [SB 1366](#) (Brodeur) **Claims Against the Government/Sovereign Immunity – Monitor** – SB 1366 will be heard on Tuesday, February 3, at 1:00 p.m. in the Senate Judiciary Committee. This is the first of three committee stops in the Senate. The League is opposed to the House Sovereign Immunity Bill, [HB 145](#) (McFarland).

Matt Singer Update:

- [SB 558](#) (Burgess) and [HB 239](#) (Grow) **Standards for Storm Water Systems – Oppose** – Last week, SB 558 passed its first committee of reference, the Senate Environment and Natural Resources Committee, and has two more committee stops in the Senate. HB 239 has three committee references and has not yet received a committee hearing.
- [SB 290](#) (Truenow) **Department of Agriculture and Consumer Services/Farm Bill – Oppose** – SB 290 was temporarily postponed in the Senate Rules Committee last week. The bill is not on the committee's agenda for this week. Rules is the last committee stop in the Senate.
- [SB 1230](#) (Harrell) and [HB 1019](#) (Conerly) **Perfluoroalkyl and Polyfluoroalkyl Substances/PFAS – Monitor** – SB 1230 will be heard on Wednesday, February 4, at 3:45 p.m. in the Senate Appropriations Committee on Agriculture, Environment, and General Government. This is the second of three committee stops in the Senate. HB 1019 passed its first committee of reference and has two more committee stops in the House.

Rebecca O'Hara Update:

- [SB 526](#) (Grall) and [HB 405](#) (Griffitts) **Commercial Construction Projects – Oppose** – SB 526 will be heard today, February 2, at 3:30 p.m. in the Senate Governmental Oversight and Accountability Committee. This is the second of three committee stops in the Senate. HB 405 has passed all committees of reference and is now eligible for consideration by the full House.

- **SB 1724** (Martin) and **HB 1451** (Busatta) **Utility Services** – **Oppose** – SB 1724 will be heard on Tuesday, February 3, at 1:00 p.m. in the Senate Regulated Industries Committee. This is the first of three committee stops in the Senate. HB 1451 has three committee references and has not yet received a committee hearing.
- **SB 1014** (Mayfield) and **HB 1075** (Sirois) **Provision of Municipal Utility Service to Owners Outside the Municipal Limits** – **Oppose** – SB 1014 will be heard on Tuesday, February 3, at 1:00 p.m. in the Senate Regulated Industries Committee. This is the first of three committee stops in the Senate. HB 1075 passed its first committee of reference last week and has two more committee stops in the House.
- **SB 1342** (Rouson) and **HB 1183** (Cross) **Transportation Infrastructure Land Development Regulations** – **Oppose** – SB 1342 will be heard on Tuesday, February 3, at 3:30 p.m. in the Senate Community Affairs Committee. This is the first of three committee stops in the Senate. HB 1183 has four committee references and has not yet received a committee hearing.

Sam Wagoner Update:

- **HB 635** (Giallombardo) and **SB 692** (Leek) **Cyber Standards and Liability** – **Monitor** – HB 635 will be heard on Tuesday, February 3, at 2:30 p.m. in the House Civil Justice & Claims Subcommittee. This is the second of three committee stops in the House. SB 692 passed its first committee of reference last week and has two more committee stops in the Senate.
- **HB 925** (Trabulsky) and **SB 1322** (Martin) **Clerks of Court** – **Oppose** – HB 925 will be heard on Tuesday, February 3, at 2:30 p.m. in the House Civil Justice & Claims Subcommittee. This is the first of three committee stops in the House. SB 1322 has three committee references and has not yet received a committee hearing.

 - **HB 1303** (Miller) and **SB 1572** (DiCeglie) **Department of Financial Services** – **Oppose** – HB 1303 has three committee references and has not yet received a committee hearing. SB 1572 also has three committee references and has not received a committee hearing.
 - **SB 1566** (DiCeglie) and **HB 1329** (Benarroch) **Local Government Spending** – **Oppose** – SB 1566 has three committee references and has not yet received a committee hearing. HB 1329 also has three committee references and has not received a committee hearing.
